NEW AIRPORT SECURITY MEASURES.

HAND BAGGAGE PROHIBITED ITEMS:

• Light firearms, other weapons and devices that shoot ammunition

Devices made to cause severe injury by throwing ammunition, or that may be wrongly considered as such due to their appearance, including the following:

- All types of firearms, including pistols, revolvers, rifles and shotguns
- o Toy weapons, firearm replicas and imitations that may be mistakenly considered as real weapons due to their appearance
- Firearm parts (excluding telescopic sights)
- Compressed air or CO2 weapons, including pistols, bb guns, rifles and pellet guns
- Starting guns and flare guns
- o Bows, crossbows and arrows
- o Harpoon guns or spear guns
- Slingshots and catapults.

Paralyzing devices

Devices specifically designed to paralyze or freeze, including the following:

- Electric shock devices, such as stun guns
- o Devices to paralyze or kill animals

 Chemicals, gases and paralyzing or disabling sprays, such as pepper, teargas, acid aerosols and spray guns to keep animals away.

• Sharp and/or cutting objects

Pointed objects or objects with sharp edges that can be used to cause severe injuries, including the following:

- Cutting tools such as axes, hatchets and blades
- Ice axes and ice picks.
- Razors, stilettos ("box cutters")
- o Pen knives with blades of more than 6 cm long
- Knives with blades of more than 6 cm long
- Scissors with blades of more than 6 cm long from the axis
- Pointed or sharp martial arts equipment
- Swords and sabers.

All blades and pointed or sharp objects of any size, transported in a simulated way within other objects (key rings, buckles, etc.) are prohibited, as well as those which are brought by the owner intentionally trying to conceal them within clothing, footwear or other types of accessories.

Working tools

Tools that can be used to cause severe injuries or damages to aircrafts, including the following:

- Iron levers
- o Drills and gimlets, including portable battery drills

- Tools with blades or handles of more than 6 cm long, that could be used as weapons, such as screwdrivers and chisels
- Saws, including portable battery saws
- Blowlamp
- Bolt pistols or nail guns

• Blunt objects

Objects that can be used to strike and cause severe injuries, including the following:

- Baseball and softball bats
- Nightsticks and sticks, such as police nightsticks and juggling props
- Martial arts equipment

• Explosives or incendiary substances or devices

Explosive or incendiary substances or devices that can be used to cause severe injury or that threaten the aircraft integrity, including the following:

- o Ammunition
- Fuses and detonators
- o Explosive device replicas or imitations
- o Mines, grenades and other explosive military items
- Pyrotechnic materials, including fireworks
- Cartridges or other types of smoke packaging (smoke bombs)
- o Dynamite, gunpowder and plastic explosives.

• Chemicals or toxic substances

- Acids and alkalis
- Corrosive or bleaching substances (mercury, chlorine, etc.)
- Neutralizing or disabling nebulizers (Mace, hot substances sprays, teargas, etc.)
- Radioactive material (for example, isotopes for medical or commercial use)
- o Poisons
- Infectious materials or materials that involve a biological risk
 (e.g. infected blood, bacteria and viruses)
- Material able to reach spontaneous combustion or inflammation
- Liquids, aerosols and gels

Introduction of containers with LAG (liquids, aerosols and gels), to sterile airfield areas or through the passengers inspection points is prohibited, unless they are kept in individual containers with a capacity not greater than 100 ml (or its equivalent); regardless of whether they are full or not, all containers must easily fit in a fully closed resalable plastic bag, of a capacity that does not exceed 1 liter (approximately 20 x 20 cm or its equivalent). It is only allowed to bring one bag per passenger.

LAG transportation in amounts greater than the ones indicated in the previous paragraph is allowed in the case of passengers with special dietary needs, such as food and beverages for baby or people under medical treatment. It is also allowed that flight or cabin crew members who wear a uniform and a valid identification of the company for which they work, transport extraordinary LAG amounts. Airport employees may introduce extraordinary amounts of foods

and beverages considered to be LAG, for own consumption in the sterile areas, but not in the aircraft.

AICM GUIDE

TIPS TO GET THROUGH AIRPORT SECURITY CHECK-POINTS FAST

- Place all your metal objects including your belt in the plastic container; otherwise the alarm will go off.
- Take all electronic devices out of their cases and place them in a separate container.
- Place all liquids, gels and aerosols in a plastic bag in a separate container.
- You may not board with liquids, gels and aerosols in amounts larger than 100 ml (3.4 oz), and these must be deposited in the containers located at the inspection point for their destruction.

LIQUIDS, GELS AND AEROSOLS

Only cosmetic or personal hygiene liquids, gels and aerosols are permitted, in individual containers no larger than 100 ml (3.4 oz.) placed in re-sealable bags with a maximum capacity of 1 liter (35 oz.) per passenger. The container must fit easily in the bag which must be completely closed, we recommend that the containers have a capacity equal to or lower than 100 ml (3.4 oz.) as larger containers are not allowed even if their content is lower.

PASSENGERS WITH SPECIAL MEDICAL NEEDS

Medication

Medication, and * baby food and milk are allowed, as well as any special diet needs. Placing these products in re-sealable plastic bags is not required as long as the amount is reasonable considering the passengers needs and itinerary.

Oxygen Tanks

Only the following are allowed:

- Medical use oxygen gas cylinders, with the corresponding medical description, and not in excess of 5 kg gross weight.
- Cylinders used in artificial mechanical limbs, and enough spare for the total or expected duration of the flight.
- Oxygen concentrators certified by the General Department of Civil Aviation, with a medical prescription.

Persons with Motor Disabilities

The use of wheelchairs, crutches, canes, etc. is allowed.

NOTE: Access with electric wheelchairs must be coordinated with the corresponding airline registration.

Differently Abled Persons

Differently valued persons traveling must be accompanied by a family member or tutor.

Persons with Pacemakers and Pregnant Women

The radiation emitted by the metal detector arch is lower than that of cellular telephones, and therefore it does not affect people with pacemakers or pregnant women; however, passengers may choose a manual revision.

Persons with Diabetes

People with diabetes may enter with the medications and syringes necessary for the flight, it is not necessary to show a medical prescription. We recommend that you travel with your diabetes patient credential.

HUMAN ASHES

Entry with human ashes is allowed presenting the cremation documents and death certificate. The urn will be inspected with x-ray equipment and explosive detectors.

HUMAN ORGANS

Human remains are permitted presenting the documentation which certifies its origin and transportation. They must be placed in a sealed container which indicates the type of organ. They will be inspected by x-ray and explosive detector equipment.

LABORATORY SAMPLES

Lab samples are permitted presenting a medical order with the signed laboratory seal and professional certificate number of the physician. They will be inspected by x-ray and explosive detector equipment.

BPARDING WITH PETS

National Flights

Entry is allowed only with guide dogs, which must be registered at the corresponding airline.

International Flights

Entry is allowed only with guide dogs or pets, which must be registered at the corresponding airline.

In the case of pets, the passenger's boarding pass must include the statement "Pet in Cabin".

SENSITIVE FILM MATERIAL rupo Aeroportuario

Film material is allowed a long as it is inspected with x-ray equipment, explosive detector equipment or manually, as defined by the manufacturer.

UNDER AGE PASSENGERS WITHOUT COMPANIONS AND SENIOR CITIZENS

Airlines offer special services for under age passengers traveling without companions and senior citizens, which consist of accompanying the passenger up to the aircraft or wheel chair service.

ADDITIONAL MEASURES FOR FLIGHTS TO THE UNITED STATES

Transporting lithium batteries in checked baggage is strictly forbidden.

As of January 2008, the United States government has prohibited the transportation of lithium batteries in checked baggage. For more information, visit the following link: www.tsa.gov/travelers/airtravel/assistant/batteries.shtm.

Transportation of liquids, gels and aerosols in hand luggage

According to international regulations, passengers may transport personal hygiene products, in liquid or cream form, gel, aerosol or mousse, in their hand luggage, as long as the container is not larger than 100 ml (3.4 oz.) and is packed in a transparent bag which can be hermetically sealed (ziploc type) and not larger than 19 X 20 cm. (7.5 X 8 in), so that it is easily examined by the authorities.

Juices, milk and baby formula or mother's milk as long as the infant is traveling, as well as prescribed medication for persons with diabetes who demonstrate their medical condition, such as insulin and other medication which does not require prescription for its sale and does not exceed the size of a 100 ml (3.4 oz.) container, including saline solutions for eye care.

According to official regulations, all liquids, gels and aerosols purchased at the airport's Duty Free stores shall be delivered to the passengers during boarding, once they and their hand luggage have passed the inspection. In the case that the passenger has a connecting flight within the United States or Canada, the products acquired at the Duty Free will be placed in checked baggage so that they are not removed by the authorities. Products

purchased on board will be delivered in transparent bags which must be kept closed until the passenger's final destination. As a guide and not limited to the following, we present a list of objects (examples), and whether or not they may be transported in hand luggage or must be stored in checked baggage.

The following are forbidden:

- Common lighters
- Torch lighters
- All-surface matches

FREQUENTLY ASKED QUESTIONS

Can I purchase water, wines and liqueurs in the final waiting area?

Yes, you may purchase any type of beverage.

If I buy perfume in the final waiting area, may I choose any size?

Yes, you may purchase perfumes or any product in the amount you wish because there are no restrictions on the amount.

If I buy perfumes or creams in the final waiting areas, may I use them before I reach my final destination?

No, items purchased in the stores located in the final waiting area will be delivered in a pre-sealed bag with its purchase ticket placed in sight, and may not be opened or used until you have reached your final destination.

Can I travel with pets?

Yes, in national flights entry is allowed only with guide dogs, which must be registered at the corresponding airline.

In international flights, guide dogs and emotional support pets are allowed, which must be registered with the corresponding airline.

In the case of pets, the passenger's boarding pass must include the statement "Pet in Cabin".

May I transport ashes or human remains?

HUMAN ASHES

Yes, entry with human ashes is allowed presenting the cremation documents and death certificate; they will be inspected with x-ray equipment and explosive detectors.

HUMAN ORGANS

Yes, human remains are permitted presenting the documentation which certifies its origin and that transportation is duly authorized by the Ministry of Health. They must be placed in a sealed container which indicates the type of organ. They will be inspected by x-ray and explosive detector equipment.

What countries and flights do the new measures apply to?

These measures apply to all flights within the AICM, both national and international. We suggest you consult the airline in the case of your return flight.

NEW AIRPORT SECURITY MEASURES.

May I transport liquids in my checked luggage?

Yes, liquids, gels and aerosols are permitted in any amount; the 100 ml restriction only applies to hand luggage.

Can any type of liquid be transported in hand luggage?

Yes, only cosmetic or personal hygiene liquids, gels and aerosols are permitted, in individual containers no larger than 100 ml (3.4 oz.) inside re-sealable bags with a maximum capacity of 1 liter (35 oz.) per passenger. The content must fit easily in the bag which must be able to close completely.

Can medication be transported?

Yes, medication, milk and baby food* and special diabetes necessities are allowed, as long as the amount is reasonable concerning the passengers needs and itinerary. Placing these products in a re-sealable plastic bag is not required.

* As long as the baby is on board the aircraft.

Can I take baby food in my hand luggage?

Yes, baby food and milk are allowed as long as the baby is on board the aircraft.

If I have special dietary needs due to an illness, can I carry it in my hand luggage?

Yes, medications and beverages for special dietary needs are permitted. Placing these products in re-sealable plastic bags is not required as long as the amount is reasonable considering the passengers needs and itinerary.

How many liquids, gels and aerosols can I carry?

Up to one liter in a re-sealable plastic bag with a maximum capacity of 1 liter (35 oz.) per passenger. The content must fit easily in the bag which must be able to close completely.

If I am on a connecting flight, can I carry liquids in my hand luggage?

Yes, all liquids, gels and aerosols must be in a re-sealable plastic bag with a maximum capacity of 1 liter (35 oz.), per passenger. The content must fit easily in the bag which must be able to close completely.

What do LAGs mean?

LAGs is the abbreviation for liquids, gels and aerosols, and include: water and other potable liquids, soups, syrups, marmalades, stews and pastas, (mole, honey, dulce de leche (milk caramel), etc.); foods cooked with sauces or with a high liquid content; lotions, cosmetics and body oils; perfumes; aerosols; gels; including hair gel and shower gel; cans with pressurized contents, (i.e. aerosols), including shaving lotion, an other lotions and deodorants; pastes, including toothpaste; mixture of liquid and solid substances; mascara; lip gloss or lip balm and any other article of similar consistence at room temperature.

Can I buy liquids at the bars, restaurants and machines at the airport to consume on the airplane?

Yes, as long as they are not alcoholic beverages and their capacity is less than 100 ml. After the inspection point: The liquids purchased at these points of sale may be taken on the aircraft as long as the flight's destination is the United States.

If I buy a liquid or gel which is inside a box, do have to take it out of its box?

No, this is not necessary; we recommend that you keep it in its pre-sealed box or bag, with the sale ticket in sight until you reach your destination.

Is there a limit to the amount of liquid or gel products I can purchase at the Duty Free stores?

No, there is no limit to these purchases; however, it is recommended that you corroborate this with your airline.

Do people with pace-makers and pregnant women have to go through the metal detector arches?

Yes, the radiation emitted by the metal detector arch is lower than that of cellular telephones, and therefore it does not affect people with pacemakers or pregnant women; however, passengers may choose a manual revision.

Can I carry alcoholic beverages in my checked baggage?

Yes, alcoholic beverages are permitted in checked baggage as long as it does not exceed 5 liters.

Are nail clippers allowed in my hand luggage?

Yes, only nail clippers without a blade or file are allowed.

What if liquids, gels or aerosols are not in a bag?

Entry will not be permitted, remember that all liquids, gels and aerosols must be in a resealable plastic bag with a maximum capacity of 1 liter (35 oz.), per passenger.

Can I carry a bottle larger than 100 ml (3.4 oz.) if the content is less than that?

No, no liquids, gels or aerosols may be carried in a container larger than 100 ml (3.4 oz.); remember that only individual containers with a capacity under 100 ml (3.4 oz.) are allowed.

Can I travel with electronic devices?

Yes, electronic devices such as laptops, cell phones, cameras, music players, etc, are allowed. Remember that when you cross the security inspection point you must remove them from their case and place them on a separate container.

Can people who need oxygen tanks travel with them?

Only the following are allowed:

 Medical use oxygen gas cylinders, with the corresponding medical description, and not in excess of 5 kg gross weight.

- Cylinders used in artificial mechanical limbs, and enough spare for the total or expected duration of the flight.

Can wheel chairs board the plane?

Can I carry syringes with needles in my hand luggage?

Yes, if the person has diabetes or the passenger's illness so requires, medication is allowed including a reasonable amount of needles considering the passengers needs and itinerary.
