

LETTER FOR RECEIPT AND USE OF PROVISIONAL PERMIT WITH PHOTO

VISITOR WITH PROVISIONAL PERMISSION WITH PHOTO -PPP- AGREES TO OBEY THE FOLLOWING:

- * UPON SUBMITTING THE LETTER, HE/SHE MUST PRESENT A VALID ORIGINAL AND COPY OF OFFICIAL PHOTO ID IN GOOD CONDITION (VOTER CARD, DRIVER'S LICENSE, PASSPORT, MILITARY SERVICE CARD, OR PROFESSIONAL CREDENTIAL, OR IMSS DOCUMENT (ADIMSS). THIS COPY SHALL BE CHECKED AGAINST THE ORIGINAL, RETURNING THE LATTER AND BRINGING THE COPY FOR REFERENCE.
- * THIS PERMIT PROVIDES FOR 24 HOURS OF USE AFTER ISSUE.
- * CARRYING THIS DOES NOT EXCUSE ONE FROM SEARCH AT SECURITY INSPECTION POINTS.
- * IT IS NOT TRANSFERABLE AND MUST BE WORN VISIBLY AT CHEST LEVEL DURING THE TIME THE INDIVIDUAL IS IN AIRPORT FACILITIES, SO THAT SECURITY MAY CHECK IT AT ANY TIME.
- * THE HOLDER ONLY HAS ACCESS TO THE AREA APPROVED BY THE PERMIT, REQUIRING ESCORT AT ALL TIMES.
- * MISUSE OF THE PPP WILL BE PUNISHED BY THE AIRPORT AUTHORITY, SO THE APPLICANT IS LIABLE
- * THE HOLDER MUST RETURN THE PPP WITHIN A MAXIMUM OF 48 HOURS FROM ISSUE TO THE OFFICE WHERE THE APPLICATION WAS MADE; OTHERWISE, THEY WILL BE LIABLE TO A FINE EQUIVALENT TO \$50 00- FIFTY MEXICAN PESOS 00/100.- PLUS TAXES PER DAY FOR LATE DELIVERY. PAYMENT MUST BE MADE TO THE AICM GENERAL ACCOUNT. THIS FINE MUST BE PAID WITHIN A MAXIMUM OF 48 HOURS; OTHERWISE THE PENALTY ACCUMULATES FOR EVERY DAY LATE.
- * IN CASE OF LOSS OF THE PPP, THIS SHALL IMMEDIATELY BE REPORTED TO THE OFFICE WHERE THE APPLICATION WAS MADE TO BE REGISTERED AND CANCELLED. ALSO, THE FINE MUST BE PAID FOR NON-RETURN OF THE CARD. FINE EQUALS \$50.00- FIFTY MEXICAN PESOS 00/100.- PLUS TAXES PER DAY THAT IT GOES UNREPORTED. PAYMENT MUST BE MADE TO THE AICM GENERAL ACCOUNT. THIS FINE MUST BE PAID WITHIN A MAXIMUM OF 48 HOURS; OTHERWISE THE PENALTY ACCUMULATES FOR EVERY DAY LATE.
- * NO NEW PPP MAY BE ISSUED BEFORE THIS DEBIT IS PAID.

ESCORTS WITH DEFINITIVE AIC AGREE TO THE FOLLOWING:

- * SHOW YOUR ORIGINAL AIC AND LEAVE A COPY IN THE WINDOW. YOU ARE RESPONSIBLE FOR THE VISITOR OBEYING INDICATIONS AND SECURITY PROCEDURES THROUGHOUT THE TIME SPENT IN AIRPORT FACILITIES.
- * YOU MUST ENSURE DELIVERY OF THE PPP, OTHERWISE YOUR AIC PRIVILEGES ARE TO BE SUSPENDED UNTIL THE TIME OF PAYMENT OF ECONOMIC SANCTIONS AS MENTIONED IN THIS NOTICE TO THE VISITOR.
